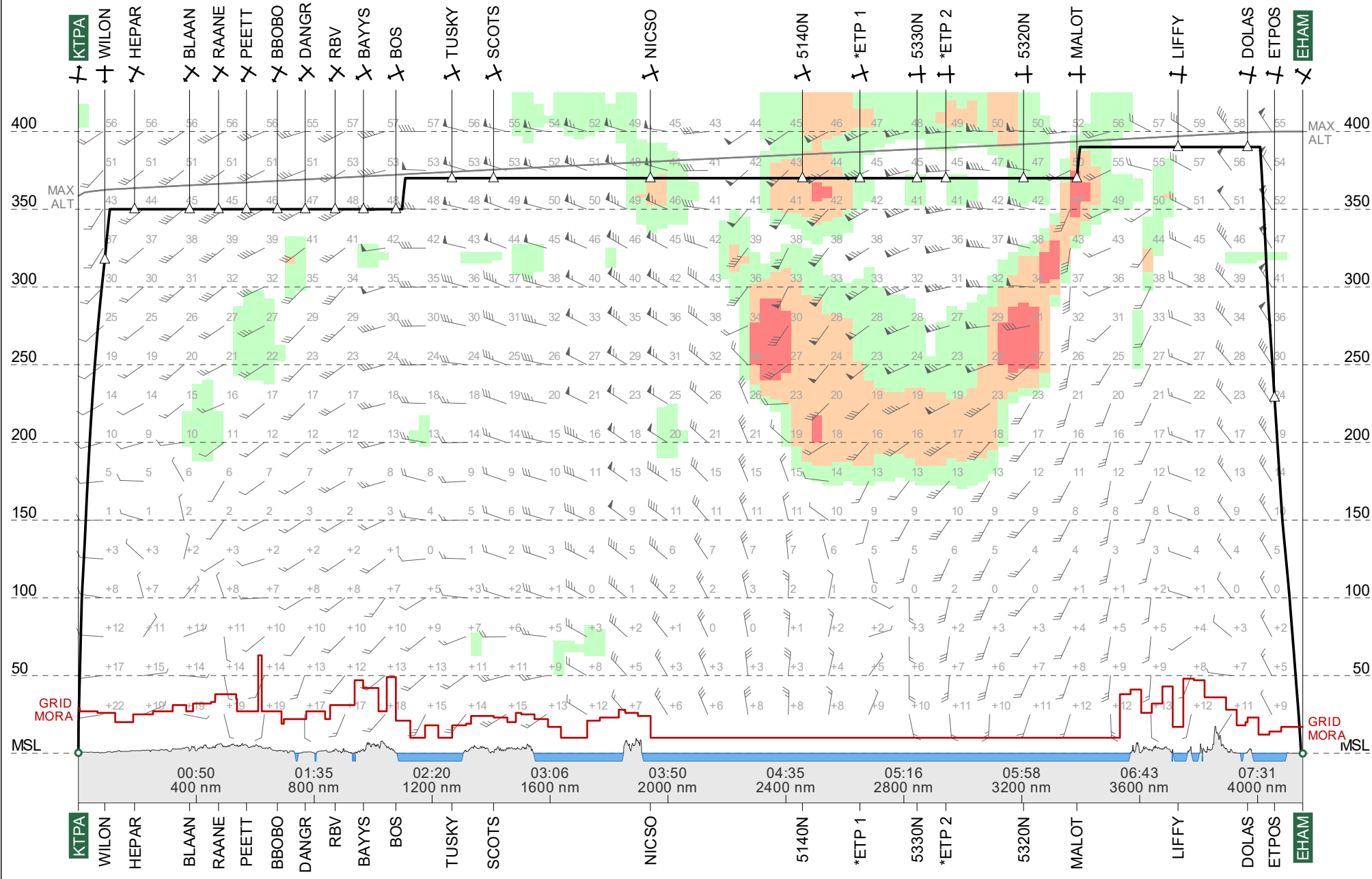

Route Chart

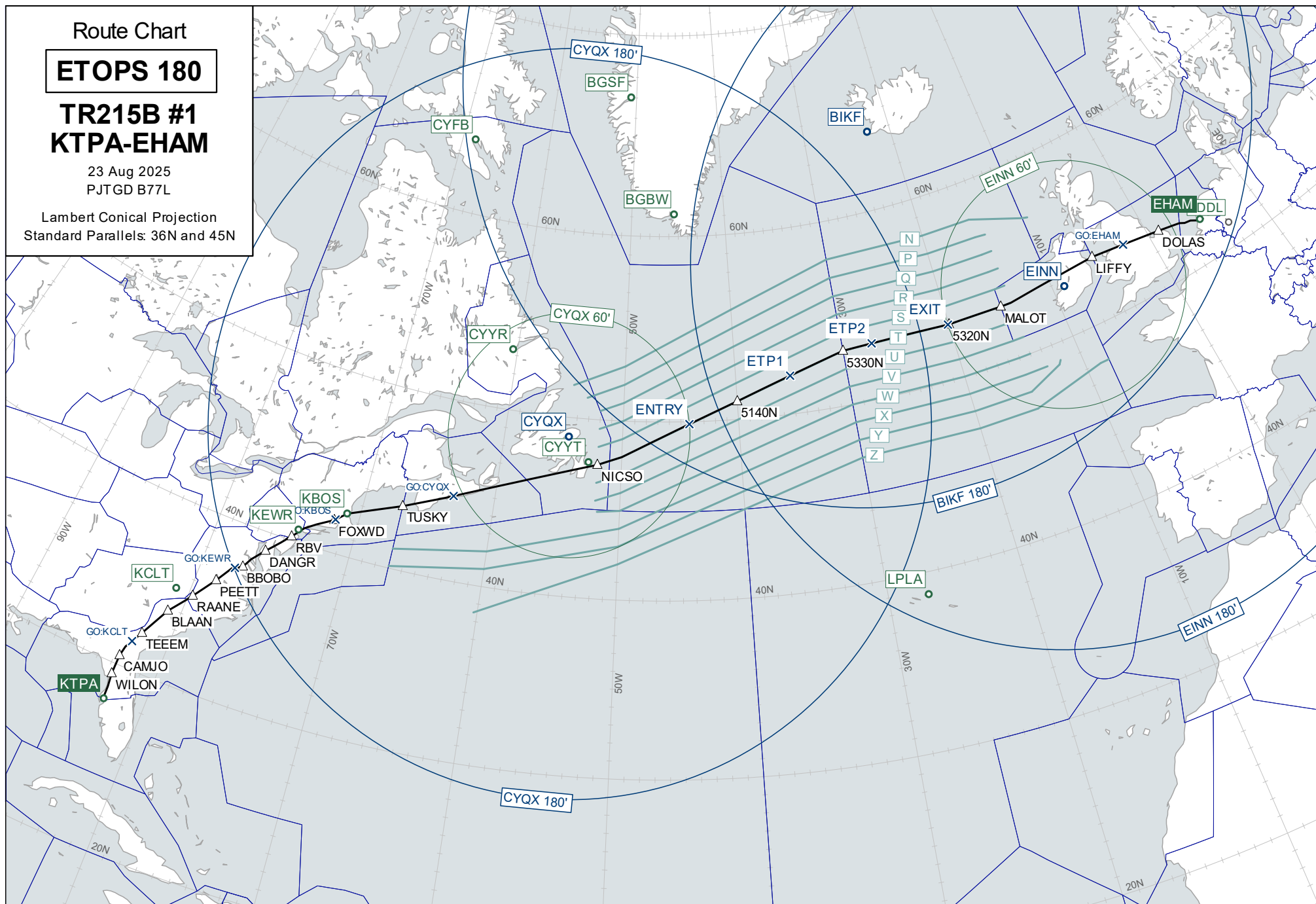
